Covid-19 Mitigation Measures Plan

COVID-19

Coronavirus disease (COVID-19) is an infectious disease caused by a newly discovered coronavirus.

Most people who fall sick with COVID-19 will experience mild to moderate symptoms and recover without special treatment.

HOW IT SPREADS

The virus that causes COVID-19 is mainly transmitted through droplets generated when an infected person coughs, sneezes, or exhales. These droplets are too heavy to hang in the air, and quickly fall on floors or surfaces.

You can be infected by breathing in the virus if you are within close proximity of someone who has COVID-19, or by touching a contaminated surface and then your eyes, nose or mouth.

SYMPTOMS

COVID-19 affects different people in different ways. Most infected people will develop mild to moderate illness and recover without hospitalization.

Most common symptoms: fever, dry cough, tiredness.

Less common symptoms: aches and pains, sore throat, diarrhea, conjunctivitis, headache, loss of taste or smell, a rash on skin, or discoloration of fingers or toes

PREVENTION

Protect yourself and others around you by knowing the facts and taking appropriate precautions.

To prevent the spread of COVID-19:

- Clean your hands often. Use soap and water, or an alcohol-based hand rub.
- Maintain a safe distance from anyone who is coughing or sneezing.
- Wear a mask when physical distancing is not possible.
- Don't touch your eyes, nose or mouth.
- Cover your nose and mouth with your bent elbow or a tissue when you cough or sneeze.
- Stay home if you feel unwell.
- If you have a fever, cough and difficulty breathing, seek medical attention.



Masks

Masks can help prevent the spread of the virus from the person wearing the mask to others. Masks alone do not protect against COVID-19, and should be combined with physical distancing and hand hygiene.

TREATMENT

To date, there are no specific medicines for COVID-19, but there are different vaccines. Treatments are under investigation, and will be tested through clinical trials

Medical treatments

If you have mild symptoms and are otherwise healthy, self-isolate and contact your medical provider or a COVID-19 information line for advice.

Seek medical care if you have a fever, a cough, and difficulty breathing. Call in advance.

ACCESS TO COMPETITION AREA

Vet-Gate area (which includes the recovery area, vetting area and hold area), the stables area and other areas (secretariat, parking lots, etc.) will have access limited with fences, tape, etc.

Access to the competition area will be subject to an access control in which access will only be allowed to personnel who have been accredited and are identified.

Identification: In addition to the mandatory bibs, every accredited person must be identified with armbands that allows to quickly and visibly identify, including:

- Officials (including timekeepers)
- Members of the Organizing Committee
- Athletes and Crew Members
- Authorities and sponsors
- Any other person related to the competition

All accredited personnel, including Athletes and Crew Members, must wear a mask as soon as they interact with Officials, members of the Organizing Committee and other participants.

It is recommended for athletes to wear a face mask or similar covers while riding on the course.

Vetting area will be redesigned to meet the following requirements:

• 4 trotting lanes with interval of 2m between them x 40m long + 2m at each end.

Crew points: They are considered part of the competition area and the same precautions must be maintained as those dictated for the Vet-Gate area. The number of Crew Members will be limited to 2 per horse, to reduce the possibility of influx.



PARTICIPATION IN THE COMPETITION

The space of the hold area will be divided by 25 sq.m. per each horse.

COMPETITION PROCESS

Maximum 2 Crew Members per horse are allowed.

There must be 2m distance between paddocks.

Maximum of two persons wearing a mask can enter the vetting area with a horse.

Spectators are not allowed.

SECRETARY

Payment of entry fees must be made only via bank transfer.

Payment of entry fees by cash is not allowed.

OTHER REQUIREMENTS

There will be no awards ceremony as such. The top 3 winners will be communicated, who will collect the trophies and / or prizes individually to the event secretary.

The distance of 2m between people must always be maintained, except for those who are part of the same team.

In the event of feeding, it will be limited to offering only a take-away service and must guarantee adequate hygiene and disinfection for its operation.

The toilets must have been disinfected in the appropriate way before the start of the competition, in case of competition of more than one day, another disinfection must be carried out at the end of the first day.

Full assumption of all general measures of the health authorities.



EHV-1 BIOSECURITY CONTINGENCY PLAN

The EHV-1 Biosecurity Contingency Plan is produced according to the FEI Horse Health Requirements 2022 for protecting horses and equestrian sports from the consequences of infectious diseases transmitted before during and after FEI events.

Assessment of the biological risk related to the sudden emergency linked to the spread of Equine Herpes Virus (EHV-1 – neurological form).

Estonia is on the list of the countries that need measures for safe return to competitions after the spread of the EHV-1. This Biosecurity Contingency Plan offers preventive and protective measures aimed at minimizing the risk of contagion.

This important document must be brought to the attention and acknowledged by anyone participating in the Padise Endurance Festival 2022.

INTRODUCTION

General Description

The EHV virus occurs in 4 different types that affect 4 different systems of the horse, in this case the most lethal and contagious is that of type 1, said also EHV-1.

The most common form is type 1 which affects the respiratory system of the horse. In the most common form, it presents respiratory diseases with variable symptoms that include fever, nasal discharge, swollen lymph nodes, cough, loss of appetite and significant physiological drops, which are quite common symptoms and can be misleading and alarming those who observe the horse.

In more serious cases, the Herpes Virus can also have repercussions from a neurological point of view, leading to paralysis and death.

Method of transmission

The EHV-1 virus, also known as Rhino pneumonia, has an extremely high viral load and is very easily transmitted by air, by direct contact between horses and also through surfaces that have come into contact with the viral components. For this reason, both sporting events and daily life in individual stables can be dangerous if the necessary precautions are not taken. It is possible, however, that horses spread the Equine Herpes Virus even without showing clinical signs (the so-called asymptomatic carriers), transmitting it only in certain environmental conditions such as stress, transport and competitions.

Diagnosis

Observing symptoms, especially at the respiratory level, cannot always lead to a correct diagnosis of Rhino pneumonia, so in these cases it is categorically recommended to contact a veterinarian who can evaluate all the hypotheses. Using a classic swab or serological tests, it is possible to establish whether a respiratory infection is associated with EHV-1, by taking two blood samples 10 days apart on which the antibody titration is carried out.

Treatment and convalescence

Unfortunately, being a virus, there is no specific and targeted cure. Treatment of equine herpes virus respiratory infections usually consists of supportive therapy, as human anti-herpes drugs are not effective in horses. Antipyretics and antitussives are administered, but also antibiotics to prevent or fight secondary bacterial infections, and to shorten the recovery period. However, with the help of a veterinary expert, a



cure can be identified to treat the symptoms resulting from EHV-1 such as general weakness, loss of appetite and apathy. It is possible to preserve his respiratory health in a preventive manner through alternative method recommended by us such as purified hay. However, in summary, the only remedies are prevention and the vaccine.

Prevention

In order to reduce the incidence of EHV-1 infection and to minimize its spread, it is necessary to sanitize the living environments of horses combined with particularly thorough hygiene through disinfectants. The isolation of the horse and tools is mandatory in case of contact with the virus.

The prevention of contagion depends on the probability that horses have of coming into contact with the virus emitted by a sick person or a healthy carrier (a healthy carrier is defined as the person who, even if contaminated, does not show symptoms or because it is too early to manifest them or because will never manifest being able to eliminate the virus autonomously).

PHASES OF RISK CONTOL

Risk control is divided into three phases:

PHASE 1: RISK ASSESSMENT - The first risk assessment must be carried out individually by each horse owner / athlete who will have access to the Event by estimating the risk index associated with their own horse based on the venue structure, maps and obligatory routes to follow.

PHASE 2: RISK MANAGEMENT - All the procedures aimed at permanently removing or constantly containing the criticalities identified in the risk assessment phase.

PHASE 3 RISK COMMUNICATION - All actions aimed at informing, training and raise awareness about horse health advice before and during the event.

RISK ANALYSIS

1. VENUE

1.1. Risk of entry of a positive or potential positive EHV-1 infection horse:

- Performing the Examination on Arrival as per Art. 1031 of the FEI Veterinary Regulations.
- Checking the FEI Equine Health Self-Certification Form in the FEI HorseApp.
- The VSM will not authorize entry to noncompliant horses whose owners may be subjected to sanctions outlined in Annex VI of the FEI Veterinary Regulations.

2. STABLES

2.1. Contact with horses:

- Corridors with one-way systems (entrance-exit).
- Prohibition to saddle in the corridor.
- Max 16 boxes per row.
- Visible stables map.
- Boxes disinfected and sealed.

- Obligation to measure the temperature of the horses twice a day and to enter it in the FEI HorseApp.
- Use personal water buckets and do not immerse water hose in buckets.
- Absolute prohibition to drink from common troughs.
- Visual monitoring by the Stable Manager and the security service and a Steward.

2.2. Permanence of the virus on the surfaces of equipment used by horses:

- Sanitizing of surfaces with spray.
- Obligation to wash hands with gel in and out of the stables.
- Visual monitoring by Steward and Security Service.

3. ISOLATION AREA

3.1. Contact with horses:

- Strictly limit access to only personnel who are looking after the horses.
- Clothing and footwear worn in the restricted area are not worn elsewhere.

3.2. Permanence of the virus on the surfaces of equipment used by horses:

- Disinfectant spray.
- Visual monitoring by Security Service.

4. VET GATE

4.1. Contact with horses:

- Restricted accesses. Max 1 person + the rider per horse.
- Determination of the maximum number of visiting horses.
- Visual monitoring by Steward.

5. COOLING AREA AND REST AREA

5.1. Contact with horses:

- Access allowed max 2 people + the rider per horse.
- Prohibition of common watering. Horses must drink from their own containers and must be bathed using their own containers.
- Visual monitoring by Steward and Security Service.

6. START / FINISH

6.1. Contact with horses:

- Large area that ensures adequate distance between horses.
- Visual monitoring by Ground Jury.

7. CREW POINTS

7.1. Gathering of people

- Access allowed max 2 crew members.
- 2 crew members will be identified differently by the crew members who are at the vet gate.
- Visual monitoring by Stewards.



PROCEDURES FOR PREVENTING EHV-1 INFECTION

- 1. Correct behavior of the riders within the place of the event.
- 2. Visitors must strictly comply with the instructions given by the OC which are considered accepted from the moment of registration.
- 3. Correct information and awareness of correct behavior is considered the first and most important means of managing risk.
- 4. The OC will have to provide suitable signs, encouraging the dissemination of messages and raising awareness of behaviors.
- 5. In order to inform and train the athletes and their crew, Officials and all the staff, correct information on the correct behaviors to prevent the spread of the EHV-1 virus must be visible in the Office:
 - obligation to wash hands with gel at the entrance and exit of the stables,
 - obligation for horses to drink water by individual containers,
 - obligation to read well this document in order to be properly informed about the procedures for fighting the infection,
 - obligation to enter the two daily temperature recordings in the FEI HorseApp on a daily basis for 3 days prior to the arrival at an FEI event,
 - obligation to enter the two daily temperature recordings in the FEI HorseApp on a daily basis for each Horse whilst at an FEI Event,
 - obligation to observe the entry and exit from the stables as indicated by the OC,
 - obligation to saddle the horse inside the assigned box and to use only personal harness,
 - any information the Event Director deems useful for risk management.

Personal Hygiene

The correct application of preventive measures, such as hand hygiene, can reduce the risk of infection. The OC provides special dispensers of alcoholic gels with an alcohol concentration of 60-85%.

Emergency procedure in case of entry of a horse suspected of EHV-1

If a horse exhibits the symptoms of the EHV-1 virus, the VSM will immediately arrange the movement to the isolation area prepared in advance by the OC and will proceed with the provisions of the Veterinary Regulations. The OC will arrange for the immediate disinfection of the box used.

Verification and review of the document

Verification and review of the document consist in the evaluation of all the activities provided for in this document and implemented for the prevention and control of the EHV-1 risk, in order to evaluate their effectiveness.

Therefore, the OC will adapt this document to any regulatory changes that will occur from today's date to the date of carrying out the sporting event.

IV. THE FEI CODE OF CONDUCT FOR THE WELFARE OF THE HORSE

The Fédération Equestre Internationale (FEI) expects all those involved in international equestrian sport to adhere to the FEI's Code of Conduct and to acknowledge and accept that at all times the welfare of the horse must be paramount and must never be subordinated to competitive or commercial influences.

- 1. At all stages during the preparation and training of competition horses, welfare must take precedence over all other demands. This includes good horse management, training methods, farriery and tack, and transportation.
- 2. Horses and competitors must be fit, competent and in good health before they are allowed to compete. This encompasses medication use, surgical procedures that threaten welfare or safety, pregnancy in mares and the misuse of aids.
- 3. Events must not prejudice horse welfare. This involves paying careful attention to the competition areas, ground surfaces, weather conditions, stabling, site safety and fitness of the horse for onward travel after the event.
- 4. Every effort must be made to ensure that horses receive proper attention after they have competed and that they are treated humanely when their competition careers are over. This covers proper veterinary care, competition injuries, euthanasia and retirement.
- 5. The FEI urges all involved with the sport to attain the highest levels of education in their areas of expertise.

FEI Passports or FEI Recognition Cards (for those Horses with a national passport approved by the FEI) are compulsory for FEI Events.

NB: Horses entered in CIMs in their country of residence are not required to have an FEI Passport or FEI Recognition Card but must be properly registered with the FEI and identifiable (FEI General Regulations, Art. 137.2).

Athletes who do not present a Horse's Passport and/or Recognition Card, or one that is not correctly validated or fail to meet other passport requirements will be **subject to Sanctions in accordance with Annex VI of the FEI Veterinary Regulations** and may not be allowed to compete.

NB for Horses permanently resident in a Member State of the European Union: all Horses must have a national EU passport in compliance with EU Regulations to which a FEI Recognition card is applied. The exception to this being Horses in possession of an FEI passport which has been continually revalidated without interruption.

7.2 VACCINATIONS - EQUINE INFLUENZA. FEI Veterinary Regulations, Art. 1003

Horses competing at FEI Events must comply with the requirements for Equine Influenza vaccination in accordance with the Veterinary Regulations and as summarised below.

VACCINATION	PROTOCOL	ELIGIBILITY TO ENTER VENUE
Primary Course	1 st Vaccination: day 0 2 nd Vaccination: day 21-92	May compete 7 days after the 2 nd Vaccination
First Booster	Within 7 months of the 2 nd vaccination of the Primary Course	May compete for 6 months +21 days after the 2 nd vaccination of the Primary Course Must not compete in the 7 days after receiving a vaccination
Boosters	MINIMUM: within one year of previous booster vaccination IF COMPETING: must be in the 6 months +21 days of the booster previous vaccination	Must have been vaccinated within 6 months +21 days before arriving at the Event Must not compete in the 7 days after receiving a vaccination



All FEI registered Horses intending to compete at FEI Events (including CIMs) must be vaccinated against Equine Influenza in accordance with these Veterinary Regulations. The exception being if the applicable domestic legislation prevents the use of Equine Influenza vaccines within the relevant territory.

7.3 EXAMINATION ON ARRIVAL. FEI Veterinary Regulations, Art. 1031

On arrival at an Event venue, all Horses must undergo an examination by a veterinarian to confirm their identification from their passport and micro-chip ID (where present), their vaccination status and general health. To protect all horses attending events, any Horse with a questionable health status concerning vaccination, disease or other concerns, must be stabled within the isolation facilities provided by the Organising Committee pending a decision on entering the venue. PRs must fulfil the Horse Health Requirements via the FEI HorseApp in advance of the event which will be checked at the Examination on Arrival.

7.4 HORSE INSPECTIONS. FEI Veterinary Regulations, Art. 1034-1042

All Horses will be assessed for their fitness to compete during the Horse Inspection. Any Horse demonstrating questionable fitness may be referred to the Holding Box for further veterinary examination. Horses not deemed fit to compete by the Inspection Panel will not be permitted to compete.

7.5 LIMB SENSITIVITY EXAMINATION. FEI Veterinary Regulations, Art. 1048-1053 and Annex VIII

All Horses are subject to examination under the protocol for abnormal limb sensitivity throughout the period of an Event. For Jumping that includes, but is not limited to, between rounds and before the Jump Off. For Endurance that includes, but is not limited to, preride, during the ride and after the ride. Horses may be examined once or on multiple occasions during the Period of an Event. Horses may be selected for examination under the protocol randomly or they may be targeted. All Horses selected to be tested must submit promptly to the examination or are subject to immediate disqualification. There is no obligation to examine any specific number of Horses at an Event.

8. EQUINE ANTI-DOPING AND CONTROLLED MEDICATION PROGRAMME (EADCMP). FEI Regulations, Chapter VII

8.1 SAMPLING. FEI Veterinary Regulations, Chapter VII

All horses competing at FEI Events may be subject to sampling for the presence of Prohibited Substances in accordance with the Anti-Doping and Controlled Medication Regulations (EADCMRs). Horses may be selected for sampling in accordance with obligatory testing, targeted or random sampling procedures. Refer to FEI Financial Charges for details of fees relating to Equine and Human Anti-Doping program (EADCMP), which OCs/NFs have the right to charge to the athlete (applicable for all FEI events worldwide).

8.2 ELECTIVE TESTING. FEI Veterinary Regulations, Art. 1058

Elective Testing may be carried out prior to an Event to check for the presence of Prohibited Substances. Please refer to https://inside.fei.org/fei/cleansport/horses for information and details.



XIV. HUMAN ANTI-DOPING

Athletes can be tested at any FEI Event, by the FEI or by other Anti-Doping Organisations with Testing jurisdiction. Organisers will have the responsibility to provide facilities and staff/volunteers to facilitate such Testing if requested by the FEI as outlined in article 22.3 of the FEIs' Anti-doping Rules for Human Athletes (ADRHA).

XV. ADDITIONAL INFORMATION

1. THE FEI POLICY FOR ENHANCED COMPETITION SAFETY DURING THE COVID-19 PANDEMIC

The FEI Policy for Enhanced Competition Safety during the Covid-19 Pandemic ("Policy") https://inside.fei.org/fei/covid-19/return-to-play/policy-tools is mandatory and applies for any FEI Event taking place as of 1 July 2020. The Policy has been developed based on currently accepted best practices by the WHO and US Center for Disease Control (CDC) and will be continually reviewed and updated as more information becomes available. It is not intended to replace the applicable guidance and policies from domestic government and health authorities, but to supplement their recommendations with sport specific considerations.

The OC shall submit the risk mitigation plan (including name and contact details of the person in charge) to the FEI as an annex to the Event Schedule, at <u>the latest ten (10)</u> <u>working days before the event's deadline for Definite Entries</u>.

Events for which the FEI has not received the documented risk assessment and mitigation measures plan in accordance with article 2.1.g) of the Policy will be removed from the FEI calendar in accordance with Article 112.3 of the FEI General Regulations.

ASSUMPTION OF RISK / WAIVER OF LIABILITY

In consideration of being allowed to participate in the Event and related activities, all Participants (as defined in the Policy) acknowledge, appreciate, and agree that:

- Participation includes possible exposure to and illness from infectious diseases including but not limited to COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist; and,
- 2. The Participants knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of the OC or others, and assume full responsibility for their participation; and,
- 3. The Participants willingly agree to comply with the stated and customary terms and conditions for participation as regards protection against infectious diseases. If, however, a Participant observes any unusual or significant hazard during his/her presence or participation, the Participant will remove himself/herself from participation and bring such to the attention of the nearest official immediately; and,
- 4. The Participants, for themselves and on behalf of their heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS THE OC AND THE FEI, their officers, officials, agents, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event ("RELEASEES"), WITH RESPECT TO ANY AND ALL ILLNESS, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF RELEASEES OR OTHERWISE, to the fullest extent permitted by law.

The Participants confirm to have read this release of liability and assumption of risk agreement, fully understand its terms, understand that they have given up substantial rights.



2. Insurances And National Requirements

In exceptional circumstances, together with the approval of Chefs d'Equipe, host NF delegate, if any, and the Ground Jury, the Organiser may change the schedule in order to clarify any matter arising from an omission or due to unforeseen circumstances. Any such changes must be notified to all athletes and officials as soon as possible and they must be reported to the FEI Secretary General by the Technical Delegate.

2.1 ATHLETES, OWNERS AND SUPPORT PERSONNEL

2.1.1 Personal Accident and Health Insurance

It is your responsibility as an Athlete/Owner/ Support Personnel to ensure that you have adequate personal accident insurance in place to cover your participation at FEI Events and in particular to insure against any personal injury or medical expenses arising from an accident, injury or illness which may occur at a FEI Event.

You should check with your National Federation to confirm if your National Federation's insurance policy (if any) covers personal accidents and/or illnesses which may occur when you are attending at/participating in FEI Events.

If your National Federation does not have a personal accident/health insurance policy or if the National Federation's insurance policy does not cover personal accident or health claims, then you should obtain your own personal accident and health insurance policy to cover your attendance/participation at FEI Events.

2.1.2 Personal Property Insurance

You should also ensure that you are insured against property loss, theft or damage which may occur at an FEI Event.

Again, the advice is to check with your National Federation to confirm if they have an insurance policy in place which would cover you in case of such property loss, theft or damage. If not, then you should obtain your own personal property insurance to cover such situations.

2.1.3 Press Equipment

Press equipment and other items left in the Press workroom, Press lockers, the Press Tribune or anywhere on the showgrounds are left entirely at the owner's risk. The Organising Committee does not accept any responsibility for any loss or damage to such equipment or items. Members of the Press are advised not to leave any equipment or personal items unattended.

2.2 ATHLETES AND OWNERS

2.2.1 Third Party Liability Insurance

As an Athlete/Owner you are personally responsible for damages to third parties caused by you, your employees, Support Personnel, your agents or your Horses. You are, therefore, strongly advised to take out third-party liability insurance providing full coverage in relation to FEI Events at home and abroad, and to keep the policy up to date.

The FEI and the Organiser will NOT be responsible for any damage caused to third parties by you, your employees, Support Personnel, your agents or your Horses.

2.2.2 Additional Liability Information

2.2.3 Horse Insurance

As an Owner you should ensure that your Horses are adequately insured against any injuries or illnesses they may sustain while participating at a FEI Event.

<u>FEI Permitted Treating Veterinarians (PTVs) (Art 1005) are to have adequate professional indemnity insurance.</u>

3. **Protests / Appeals**

To be valid, all Prostests and Appeals must be made in writing and accompagnied by a deposit of CHF150. – or equivalent.

4. Disputes

In the event of any discussion concerning the interpretation of the schedule (in translated languages), the English version will be decisive.

5. Modifications Of Schedule

In exceptional circumstances, together with the approval of Chefs d'Equipe and Ground Jury the OC reserves the right to modify the schedule in order to clarify any matter or matters arising from an omission or due to unforeseen circumstances.

Unforeseen circumstances do not include situations arising as a results of the OC altering the approved Schedule without FEI's authorisation. Any such changes must be notified to all competitors and officials as soon as possible and they must be reported to the FEI Secretary General by the Foreign Judge.

6. Additional Information from the OC

The entry fee must be paid to the bank of organizer before the closing date of the definitive entries.

7. Prize Money Distribution:

DEDUCTIONS FROM PRIZE MONEY AT COMPETITIONS

Full details of any deductions from prize money should be outlined in the schedule. This includes government taxes. If it is necessary for organisers to deduct such taxes, they should provide participants with an official form indicating the amount of tax deducted upon application.

The tax form should be provided to the athletes upon arrival and returned to the organiser prior to departing.

7.1 Total Prize Money NO PRIZE MONEY

IMPORTANT

The value of the 1st prize must not exceed 1/3 of the total prize money distributed for the competition. The minimum number of prizes offered for each competition must be allocated on the basis of one prize for every commenced four Athletes, with a minimum of five prizes. The total amount of prize money shown for each Competition in the schedule must be distributed. (Art 127, 128)

7.2 Awards

An award must be given to all competitors who complete the ride. Please describe awards to be distributed.

Please note that as per Art. 109.6 (GR): ORGANISERS of International Events must inform the FEI and NFs whose teams or individuals have taken part, of the results and prize money paid to each placed Athlete and team, within five (5) days following the Event, unless otherwise specified for qualification and ranking reasons as communicated by the FEI.

Failure from ORGANISERs of International Events to provide the FEI with the appropriate result(s) and/or prize money information by the aforesaid deadline and/or in the aforesaid format shall entail a warning for the first violation and thereafter a fine of CHF 1'000.- per violation.

The FEI may request a copy of the official PDF result signed by the relevant Officials at the Event.



FEI Endurance Organisers' Protocol

With an aim to further ensure the welfare of equine and human athletes at International Endurance Events, the safety of all participants and the implementation and respect of common principles of behaviour, fairness, and sportsmanship, the FEI has created this FEI Endurance Organiser's Protocol (hereinafter the "Endurance Protocol") to guarantee the correct and full application of the applicable FEI Rules and Regulations in your Events, in particular but not limited to, the FEI General Regulations, the FEI Endurance Rules, the FEI Veterinary Regulations, the FEI Anti-Doping Rules for Human Athletes and the FEI Equine Anti-Doping and Controlled Medication Regulations.

In order for the FEI to approve the competition schedules the Endurance Protocol **must** be signed by the Organiser and the National Federation, listing the Event(s). By signing the Endurance Protocol both aforementioned parties agree to comply with all applicable FEI Rules and Regulations, and in particular (but not limited to), with the following requirements:

- Full cooperation must be given to the FEI Officials to ensure that they can perform their tasks according to the FEI Endurance Rules, in particular:
 - Ground Jury Art. 853
 - Technical Delegate Art. 852
 - Veterinary Commission Art. 854
 - Chief Steward Art. 855
- Full cooperation must be given to the FEI Independent Governance Advisors (IGAs) to ensure that they can perform their tasks according to the FEI Endurance Rules Art. 856
- 3. The welfare of the horse must be a first priority and you must allow the FEI Officials to take all necessary measures to safeguard it, as per the FEI Endurance Rules, including but not limited to:
 - Loops of the course must not be specially designed and/or constructed to encourage high speeds - Art. 818
 - Allowing for the reduction of the pulse criteria Art. 816.9.2. The pulse criteria may be reduced during the ride if, in the opinion of the President of the Veterinary Commission in consultation with the Foreign Veterinary Delegate, the President of the Ground Jury and the Technical Delegate they believe there is a danger to the safety of the Horses.
 - The Veterinary Commission has absolute control on all matters concerning horse welfare – Annex 5, Art.1.
 - The Technical Delegate or the Ground Jury together with the Veterinary Commission can decide to modify the length of timed holds according to extreme weather conditions or other exceptional circumstances.... - Art. 816.9.3.
- 3.1 If the Event combines a CEN(s) with a CEI(s), the Organiser will take all reasonable measures to ensure the biosecurity of the FEI Horses is safeguarded including but not limited to:
 - Ensure that FEI horses participating in the CEI are stabled separately from CEN horses participating in the CEN ride. If no stabling is required at your Event, please make sure they are separated in the cooling and holding areas.
 - The use of common water troughs for Horses is prohibited. Water must be drawn with a clean bucket. Horses must not drink directly from the trough.
 - Ensure that the examination upon arrival is done for all Horses according to article 1031 of the Veterinary Rules.

It is advised that the temperature of CEN Horses is manually recorded 3 days prior to the event, and that this information is passed to the FEI Veterinarian that is carrying the Examination upon arrival.

Ensure that all participants are advised to report any health issues to the FEI Veterinarian, so that Horse can be isolated and further testing can be done.

 Ensure that the veterinarians have enough sanitizers and gloves for the Horse inspections throughout the day.

- The safety of the athletes, FEI Officials and public must be safeguarded at all times and FEI Officials must be allowed to take all necessary measures to ensure safety, as per the FEI Endurance Rules/FEI GRs:

 - Horses must remain capable of being clearly observed at all times Art. 813.5
 - Permitted Assistance during Event or on Course Art. 822.4
 - Prohibited Assistance Art. 822.5
 - Postponement and/or cancellation of an Event FEI GRs 109.12
- The FEI Officials' Code of Conduct must be adhered to including the obligations and 5. restrictions pertaining to the "Endurance Official's Per Diems".

Any breach of the FEI Rules and Regulations will be prosecuted according to the FEI Legal System (Chapter VIII of the FEI General Regulations). Failure by an Organiser to comply with the terms of this Protocol may also lead to sanctions including the removal of future events from the FEI Calendar in accordance with Article 112.3 of the FEI General Regulations.
